

**City of Millbrae
Domestic & Feral Cat Enforcement & Regulations**

Domestic Cats - Any person providing care or sustenance for 30 or more days is considered an owner of such animal. (6.12.020.C - SMC)

Millbrae Police Department/City Manager's Designee

- ❑ Limited to 3 cats over 4 months. More than 3 cats requires a permit from the Animal Control Officer (6.14.030.A - MPD/CMD)
 - Animal Control Officer means the chief of police and officers of the Millbrae police department or such other person or persons as the city manager may designate. (6.14.010.E)
- ❑ No cat owner shall permit it to damage or destroy property of any person. (6.14.020.B - MPD/CMD)

Peninsula Humane Society

- ❑ Rabies vaccination for every cat over 4 months required. The vaccination shall be obtained prior to issuing a license for the cat and proof of vaccination shall be provided to the licensing program. (6.04.030 - PHS)
- ❑ Annual license required for every cat over 4 months. (6.04.040.A - PHS)
- ❑ Cat cannot be upon any unenclosed premises unless properly licensed. (6.04.070.A - PHS)
- ❑ Cat cannot trespass upon private property without consent of property owner. Cat owner cannot knowingly permit cat to habitually continue to trespass. (6.04.070.B - PHS)

San Mateo County

- ❑ Cats over the age of six months must be spayed/neutered or obtain
 - 1) License to keep unaltered cat; or
 - 2) License to keep unaltered cat and permit for breeding cats. (6.12.020.A - SMC)

Feral or Barn Cats: Ownership as described in 6.12.020.C does not apply when a person is caring for barn or feral cats if such person:

Peninsula Humane Society

- 1) Registers with the PHS
- 2) Regularly feeds them or arranges for their daily feeding.
- 3) Traps all cats older than 8 weeks and has them spayed/neutered.
- 4) All trapped cats are tested for leukemia and those testing positive are humanly euthanized.
- 5) Identifies that the cats are spayed/neutered with ear notching.

Peninsula Humane Society/San Mateo County

- 6) All trapped cats are vaccinated according to state and local laws. (6.12.020(D) - SMC/ PHS)
